Cemetery Commission Meeting
June 21, 2022

ITEM ONE – CALL TO ORDER

Randy Mogren called the meeting to order at 5:03 p.m.
Present: Randy Mogren, Robert Roy, Keith Caruso and Amy Paquette-Riordan.

ITEM TWO – GUEST/SPEAKER:

No guests appeared.

ITEM THREE– MEETING MINUTES:

The Cemetery Commissioners reviewed, approved and signed the meeting minutes from the April 19, 2022 meeting. Bob Roy made a motion to approve the minutes as presented and a second was made by Randy Mogren.

ITEM FOUR-NEW BUSINESS:

Received a request to transfer ownership of a plot. The Commissioners agreed that they would like a written statement from David and Hudson Matson that the transfer will not be contested.

ITEM FIVE – MONUMENTS/FLAT MARKER APPROVALS:

Nothing at this time.

ITEM SIX-OLD BUSINESS:

Randy Mogren asked for an expansion update. Keith Caruso informed the commissioners that Weston & Sampson has finished pinning the cemetery. Keith is currently reviewing the roads project and will have a better idea of funding for the projects at the close of Fiscal Year 22.

Randy had asked if the two-year clock has started yet for the West Street expansion project in which Keith confirmed it has not.

Randy looked into the Dwinnell, Dwinell and Dwinel question that was raised by a resident. He stated that per a conversation with former Town Clerk David Matson the sign at Dwinnel

Cemetery in in fact spelled correctly according to the deed. Also, as far as the spelling of the road that is a question for the current Town Clerk and how it was accepted at Town Meeting.

Keith informed the commissioners that most of the one-way signs have been placed at Central Cemetery and that this is already making a positive impact there. The signage was placed in order to eliminate individuals from parking on the grass shoulders and causing ruts in the grass.

Keith also informed the commissioners that a new job posting will go up on July 1, 2022 for an additional cemetery/float person. This position will essentially be the Cemetery Foreman and will report directly to Carl Ward. This new employee's primary function will be the cemetery.

Keith also addressed the fence issue behind section eight. The staff is looking into ways to make the area more appealing. They initially tried work chips which Keith did not like. Randy Mogren and Bob Roy agreed that the wood chips were not going to work over there. Carl's primary focus will be to clean up that area and make is astatically pleasing.

Keith and the commissioners agreed that the cemetery is in better shape than it was a year ago but still needs a lot of work. This is a process and won't be done overnight. It is going to take time, effort and funding to bring the cemetery up to par. Summer help has been hired and will be used as Carl deems necessary.

ITEM EIGHT – FUTURE MEETING DATES


The Cemetery Commission will meet again on Tuesday, July 19th at 5:00 pm and again on Tuesday, August 16th at 5:00 pm.

ITEM NINE– ADJOURNMENT


Bob Roy made a motion to adjourn at 5:19 pm Randy Mogren seconded that motion.
