Discussion with Rick Bedard and Ross Bilodeau of Verizon. Selectman Despres asked about the width? Ross stated 1 foot wide. Selectman Delaney ask if this was only for the Shaw School. Ross stated yes, there are no off shoots from the conduit. Selectman McKenna asked if there would be any effect in the future or impede any future construction? Ross stated no. Report on 158 Wheelock Ave & 9 Grafton St

9 Grafton St-Paul Stringham, Building Inspector stated this issue is all taken care of. Along with help from the police department cars were taken off the roadway and any unregistered vehicles are no longer in Town.

158 Wheelock Ave-Paul stated there have been several years of illegal dumping and he has been working with the Board of Health on these issues. Housing Court kicked it out. Town Counsel recommends one last attempt to address with the owner.

Discussion on Scheduling a Workshop on Bump-outs

Mr Kelley stated there is a Public Meeting on the bumpouts tomorrow night. Selectman Despres stated that it is informational in nature, No changes can be made and the plan is set. The Board agreed no workshop is necessary. Selectman Delaney stated as a business owner he feels the bumpouts at the end of the building that his business is in are very dangerous and the speed limit has to be addressed as it is a heavily traffic area. Also there needs to be more communication. Several business owners in the area feel the same there is not enough communication.
