Selectmen Present:

Chairman Adams said that we changed things up a bit on the agenda; citizen speak is now at the beginning of the meeting.

### Citizen Speak

Joe Coggans asked the board to put the Charter Review Committee as soon as possible as many boards need to appoint the members. This is a very important committee as the town can only change the Charter every ten years and this is your chance.

Michael O'Connor thanked the vice-chair for putting citizen speak at the beginning of meeting. He talked about the Home Rule Charter and wanted to touch on petitions for the warrant need to be updated since the internet has been invented; another part is the town manager needing to change the warrant within 60 days of the warrant closing. If an article is submitted by a board, committee or citizen, the Board of Selectmen Shall put it on the warrant; he would like to know why the Medicare article was left off of the last warrant.

### Ray B. Whitehead- Ice Cream Lady 2.0- at 56 Canal Street

Mr. Whitehead said that they have all of their licenses, permits and certificates.

Motion made by Selectman Krumsiek, seconded by Selectman McKenna to grant the Common Victualler license.

Motion carried unanimously.

Selectman Despres asked if we will be getting an ice cream lady statute as well.

### John O'Rourke-Good Energy\*see attached

Over the last three years the municipal aggregation activity has picked up significantly. Good Energy is one of the top suppliers in the area. For Millbury's aggregation; we are under all of the other rates. In November, we expect Ngrid to go up to the mid 11¢.

Selectman Despres asked why with all of the mega solar farms, why isn't the rates lower? You cannot predict what solar is going to produce daily; it needs to have standby alternative energy so that drives the rate up.

### Greg Myers- RE Shaw School Feasibility Update

Mr. Myers said that this committee was formed about a year ago. We are now looking to hire an designer to do the feasibility study. There will be a meeting with the MSBA June 19<sup>th</sup> and appear before the designer panel to choose who is best options for our school. Three representatives have to go to the meeting, the Superintendent, a member of the school committee or their appointee, and a member designated by the CEO or their designee. The subcommittee has suggested having E. Bernard Plante as the CEO designee as he is the Chairman of the Committee and a former longtime selectman. If he cannot attend, the subcommittee recommends Rick Bedard as the alternate.

Chairman Adams asked how soon they need to know? Mr. Myers said the MSBA would like to know a week before the meeting; there will also be another meeting to choose the designer on July 10, 2018. The MSBA would like the person to be knowledgeable on the project.

Motion to appoint E. Bernard Plante as the CEO designee and Rick Bedard as the alternate made by Selectman Despres, seconded by Selectman Krumsiek.

Motion carried unanimously

Mr. Myers said that the original owner of the Ice Cream Lady is Douglas was a resident of Millbury who had left high school to work on B52 engines in the Korean War; he had the statute shipped to him from the Cape; they were honored to issue him his diploma with the help of Senator Moore two years ago. Selectman Adams said that the MSBA did not make a decision as to whether a renovation or complete build will be made yet.

### **Town Manager Report**

Mr. Marciello is promoting Joe Kosiba to General Foreman in the DPW and Keith Caruso as Working Foreman in the DPW. These positions were done properly through the HR Department. He is asking for ratification of a Memorandum of Agreement between the Town and the Ma Laborers Public Employee Council.

CMRPC is looking for support on amendments to change the budget that is not finalized. He would like the board to let him know what direction they would like him to go Chairman Adams if we are on target for the McCracken Rd. TIP project? We are completed on target and funded.

Mr. Marciello said that the two viable funding sources are coming together nicely. Town meeting allowed the accounts for the money from the marijuana facility.

Selectman Naff asked what makes a project "viable". The Nature's Remedy contract is giving us 3% of their sales and 3% impact; the 2<sup>nd</sup> is a solar project for town owned land that will

require them to build at the transfer station which will require three phase power which will then allow us to put in compactors that will reduce our recycling/trash pulls.

Mr. Marciello said that the data is in from the snow/ice digital spreader. We saved 30% in salt this year over last with the calibration being correct. We will add another one to a new vehicle this year and as we replace the older vehicles we will put these on as well.

The municipal lot parking issue is very low on the priority list right now as Mr. Nastasia wants to get the roads program finished up. Chairman Adams thought this would be a good discussion for the workshop.

Mr. Marciello said that with the complaints of the lights on the dam being too bright is being corrected with dimmers. The punchlist is being worked on. They hydroseeded, touched up paint and they will deliver closing documents when the punchlist is done. Then he will order the planters, which will cost around \$12,000.

The DPW is working on ADA ramps on sidewalks and the town hall parking lot.

Mr. Adams would like a sign for the handicap parking spots near the Post Office. We have to do a self-assessment for handicap accessibility.

Today was the wrap up meeting for the Municipal Vulnerability Preparedness (MVP) workshops. CMRPC is putting on a one hour listening session on Tuesday, June 12, 2018 at 6:00 pm before the next selectmen meeting. They will attend the Selectmen Meeting at 7:00 pm to review their findings. He thanked all of the department heads for pitching in and getting this done; this puts us higher on grant lists.

Chairman Adams asked if the manager would like the board to recommend support/opposition to the CMRPC budget requests.

Motion made by Selectman Krumsiek to have the town manager send a letter of support on all requested CMRPC, seconded by Selectman McKenna.

Motion carried 3-1 (Selectman Naff abstained)

Selectman Krumsiek said that she learned in her MMA meeting they discussed rideshare programs that the state collects .20 per ride and Millbury gets .10 for its share of rides used; this time we should be getting \$2,000.00. Please use Uber or Lyft!

Mr. Marciello showed a copy of Bride & Groom Magazine where there is a four page spread on Asa Waters Mansion. Kudos to the director, the task force and the friends. Mr. Naff said that they were at the Bridal Expo as well. Selectman Krumsiek said that she and selectman Naff attended an evening with Daniel Chauvin (who is also our ACO); it was a wonderful night.

Selectman Despres asked about the promotions in the DPW; was the operations manager eliminated? Yes, it is not funded for FY19. Mr. Marciello said that the working foreman and the general foreman were existing positions that were not filled. Selectman Despres would like to know what the financial impact is for having essentially two operations managers? Mr. Marciello replied that it is a net savings of \$40,000.00. We also will be hiring a laborer and having a net savings of \$10,000 with two more people working boots on the ground. Selectman Despres wants to make sure that each person hired has all of the licenses needed per the job descriptions.

Mr. Marciello cannot appoint Nick Lazzaro to the Recycling Education Committee at this time because he is not 18 years of age.


