Selectman Despres asked if this is a liability because the bank will have their name displayed on it. Mr. Marciello said no and to think of it like a trust. He checked with town counsel and the State and it is ok, just need to have the proper insurance.

7:28 PM Town Manager Report

Mr Marciello appointed Justin Dobson & Daniel Jakes to the Disability Commission. There are website delays due to the web host. ClearGov will be updated with all current budget info. There are some organizational changes, there will be an Assnt Town Planner, a position at COA it will be one tier below the Director, and an Assistant for the Veteran's Agent. Also Justine is at HR boot camp. Paving Program has started. Cement along the driveway at town hall was under warranty so Lynch is coming back to fix it. Ramshorn planters are at the DPW garage-DPW will now order stone, loam and flowers. Discussion re: National Grid, the "pigtails" and corroded connections. Chairman Adams suggested replacing them as troubleshooting is very expensive. Tip Project-letters are going back and forth between counsel and MassDot. Mrs Shriver of MassDot said to "slow down" and they have a very particular way resident questions are handled and everything needs to be documented. Chairman Adams asked that all dates be put on the Selectmen's calendar. Chairman Adams also asked who is having meetings at the McGrath School on Monday nights? Selectman Krumsiek asked about insurance for groups that want to use the town common.
