Mr. Marciello stated he plans to move some money depending on the Town Clerk. Initially she asked for new election equipment for the fall. There is specific regulatory language. Mr Marciello stated it was a bit higher but with his license, experience and it only being a temporary 6 month position he felt it was fair. He also talked about the new website-it looks great and thanked Joyce for her hard work. Mr Marciello talked about the Program Coordinator Position and Oct being the original goal to fill it by. Once the summer intern gets done his projects Mr Marciello was going to have him work on social media. If the summer intern doesn't get to the social media in the fall we will be having a BVT student work on it. He also updated the Board on the phone system. He hired a company and the bid came in lower than expected so now he is trying to expand the scope. The Library Director will be starting mid July, ads are all
