To Approve & Vote Annual Town Meeting/Election and Annual Town Meeting Warrants

Motion to close the Annual Town Meeting Warrant and the Annual Town Election Warrant by Selectman Krumsiek seconded by Selectman McKenna, and on a roll call vote with Selectman Adams, Selectman Krumsiek, Selectman Despres, Selectman Naff and Selectman McKenna, the following vote was approved 5-0.
