Laurie went over existing conditions-Elm St (West), Municipal Parking Lot, Private Parking Lots, Pedestrian Connections, Access Points, ADA Violations. Laurie then spoke about the Master Plan, Proposed Improvements, Curbside Rain Gardens, Potential Streetscape Improvements, Potential Parking lot & Access Improvements. She also went over the Project Benefits which all help make a Cleaner Blackstone River. In closing Laurie went over the estimated Project Budget, Proposed Funding Sources, and the Project Schedule.
