Town of Millbury Minutes of Cemetery Commission Meeting July 15, 2019

ITEM ONE - CALL TO ORDER

Marcia Landry called the meeting to order at 5:00 p.m.

Present: Gil Picard, Marcia Landry, Randy Mogren, Keith Caruso and Christine Billington.

ITEM TWO – GUEST/SPEAKER:

Matthew Mulhane of Mulhane Home for Funerals.

Matthew came into the meeting to talk about the vaults for the cremains. Matthew stated that sometimes it is not possible to use vaults for cremains because there is not enough room if they are going on top of a loved one in the same cemetery plot. People are buying double urns now and that is why it is making it difficult to bury with a vault, they are not making vaults big enough. Matthew wanted to ask the commission that when update their rules and regulations that they put something in about the vaults for the cremation urns. He would like to see the board adopt the same policy as the Diocese with either certain urns be used if not then they would have to use a vault.

Keith stated that they are still working under the old prices until the contract is signed by everyone. Tender Touch did go up a bit on their prices but with the cost of living and everything else it was to be expected and they also took into account winter months where they would have to remove snow and such from the grounds. The final approval will still fall under the DPW. Randy Mogren asked if they cost was passed on to the family and Keith stated that yes, the families were paying for this service. Marcia Landry stated that the Funeral Homes will need to be notified about the rate increase.

Marcia Landry wanted to congratulate Gil Picard for his reappointment to the Cemetery Commission. Marcia Landry asked the DPW if the stripe lines were complete and Keith Caruso stated that lines were done.
