#### **New Business:**

1. Public Hearing-Notice of Intent- DEP# 224-0843 - 0 West Street- Central Cemetery Town of Millbury, Department of Public Works

Mr. Stead opened the Public Hearing by saying that this project had been continued from the October 21, 2022 meeting. At that time there had not been a DEP# issued. A DEP # has since been issued with comments. The applicant submitted new revised plans that addressed DEP's comments. There was not anyone present to speak on behalf of the project. A motion to close the Public Hearing was made by Mr. DiCicco and seconded by Mr. Raymond. All in favor, motion approved. A motion to approve and issue the Order of Conditions was made by Mr. Raymond seconded by Mr. DiCicco, All in favor, motion approved.

# 2. Public Hearing- Notice of Intent- DEP# 224-0845 West Main Street- Ramshorn Culvert Replacement Project Town of Millbury, Department of Public Works

Dan Cannata and Greg Russell, from VHB, represented the Town of Millbury. Mr. Russell explained that the Town hired VHB to look at the failing culvert and too put together a plan for the work. The work will include milling and paving the area of the street impacted, as well as the replacement of the failing culvert using same size as present in same location to keep impacts low. A DEP # was issued and included some comments. The comments have been addressed by the applicant or have been added as special conditions to the Order of Conditions. A question was asked as to the timeframe of starting; Mr. Russell explained do not have a start date presently. The Town still needs to secure funding and bid out the project with the goal of a start date sometime late summer of 2023. A motion to close the public hearing was made by Mr. DiCicco seconded by Mr. Keddy. All in favor, motion approved. A motion was made to approve and issue the Order of Conditions by Mr. Raymond and seconded by Mr. DiCicco. All in favor, motion approved.

Mr. DiCicco made a motion to adjourn the meeting at 6:57 p.m., seconded by Mr. Raymond. All in favor, motion approved.
