#### MINUTES:

### **CORRESPONDENCE:**

We received a flyer from Central Mass Agency on Aging announcing Elder Care 2019 to be held at Worcester State Univ. on June 12<sup>th</sup> from 9:30 AM to1:30 PM.

We received an e-mail from Seana Weaver, from the Worcester County Food Bank informing us of a large donation from the National Association of Letter Carriers. They are recommending that we increase the amount of food we give to the families on a monthly bases. They would also like us to increase hours if possible.

Ms. O'Connor received an e-mail from Human Resources stating that she has to attend a mandatory Supervisor Safety Training Course on May 21st to be held at the Asa Waters Mansion.

We received a letter from Catholic Charities announcing extra hours for the Senior Aide program from now to June 28<sup>th</sup>.

We received a letter from MEGA's Loss Control Consultant giving us the result of the safety

survey they conducted at the Senior Center. The only thing they found was we needed a sign on the electrical closet stating that "this is not and exit". We place a sign up immediately.

We received a letter from Greenway Challenge asking if they could use the parking lot on Sept 28<sup>th</sup> from 9 AM to 10 AM for the teams to depart by bicycle after the runners arrived. The rain date is Oct. 5<sup>th</sup>.

We received a notice from All Faiths Cemetery announcing the Memorial Day services.

We received a notice asking for Senior Children and their parents to be interviewed for a reach study. Ms. O'Connor referred a daughter and mother who live together to do the interview and they would receive a monetary gift for participating.

#### STANDING REPORTS:

- A. Budget and Finance Ms. Peltier explained what happened at Town Meeting and that the COA budget passed.
- B. Personnel Ms. O'Connor explained that we have been given a Senior Aide from the Catholic Charities Program. She will start working on a job description for the new position that was approved at Town Meeting.
- C. Nominating The Board members discussed the members who are up for reappointment. The COA board cannot have more than 4 members reappointment at a time and we currently have 5. Ms. Peltier and Mr. Ayotte will work on this and meet with the Town Clerk.

- F. Building Maintenance/Equipment Ms. O'Connor reported that the Sheriff's department can and Cleaning the hill raked the back lawn and re seeded. Waiting for the irrigation unit to be repaired. Mr. Walinsky suggested we call Wheelabrator to see if they could help with the repair.

Director's Report – Ms. O'Connor reported that the office received 2 new computers and now have Window 10. We will need to have the Town add 1 more in the next fiscal year. The Town Manager has changed his dates to visit the Senior Center from the 3<sup>rd</sup> Wed. to the 3<sup>rd</sup> Tues. of the month because of Grand Jury Duty. He has also requested that all department heads attend a Mandatory OSHA safety course on May 21<sup>st</sup>. There will be 2 summer concerts (July & Aug) due to a shortage of sponsors. The Millbury Cultural Council will

sponsor 4 Ever Fab in July and One Care of Millbury will sponsor the Eddie Foreman Band in Aug. She will try to find a concert for June.

Elder Services of Worcester/Nutrition Program – There was no meeting.
