#### 2. Permit Application for Mark Smith / 61 Miles Street:

Robert Murphy started by explaining to <u>Tom Brown</u> that he would like to have the three parcels on one permit because the amount of Earth being removed from the abutting properties are below the minimum requirements. <u>Scott Despres</u> made a motion to accept Robert Murphy's request, <u>Bruce DeVault</u> second the motion. <u>Tom Brown, Scott Despres</u> and <u>Bruce DeVault</u> voted unanimous to except the request 3-0. <u>Scott Despres</u> asked Robert Murphy if he had spoken with Chief Donald Decorcy in reference to a police detail while the excavation is being performed. Robert Murphy responded that he had spoken with the chief and the planning board. <u>Tom Brown</u> stated that the application for the Earth Removal permit was in order. <u>Scott Despres</u> made a motion to grant the permit, <u>Bruce DeVault</u> second the motion. <u>Tom Brown, Scott Despres</u> and <u>Bruce DeVault</u> voted Unanimous 3-0.
