Motion by Veronica Wood, seconded by Lucy Chabot to accept the minutes of the February 19<sup>th</sup> meeting as read. All in favor. Motion carried unanimously.

Motion by Lucy Chabot, seconded by Veronica Wood to accept the February Consolidated Report Voucher in the amount of \$198,752.83. All in favor. Motion carried unanimously.

Motion by Lucy Chabot, seconded by Veronica Wood, to accept the February MRVP Voucher Report in the amount of \$1,858.00. All in favor. Motion carried unanimously.

Motion by Sherry Forleo, seconded by Veronica Wood to accept the March Consolidated Voucher Report in the amount of \$129,547.12. All in favor. Motion carried unanimously.

Motion by Sherry Forleo, seconded by Lucy Chabot to accept the March MRVP Voucher Report in the amount of \$1,858.00. All in favor. Motion carried unanimously.

Carol informed the Board that it was reported that Robert Spain has returned from Florida, but she hadn't heard anything from him regarding the bus stop. She also stated that she has contacted the town manager and he hasn't responded to her email. She asked for suggestions, and I was decided that we would table it until the next meeting.

Carol made the Board aware that the architectural work has been started on both Riverlin and Waters Streets. Waters Street requires a civil engineer to determine how and why there is water in the basement. This report will be available within the next 3 weeks.

Staff vacations...Discussion was held regarding allowing the staff to roll over vacation time due to the Covid-19 situation. Tom Austin has the most time, 6.35 weeks, and Carol requested that the Board take exception to their previous policy mandating all accrued vacation be used within 3-5 years, and no longer being allowed to accrue.

Carol informed the Board that the annual Mass NAHRO Conference has been changed from this month to September, although Carol feels that it will probably be cancelled.

Motion by Veronica Wood, seconded by Lucy Chabot to adjourn. All in favor. Motion carried unanimously.
