Call to Order: Jeff Raymond called the meeting to order at 6:05PM.

**New Library Director Update:** The candidate selected by the board withdrew on July 1<sup>st</sup>. The board has named Ann Dallair the new Director. Eric Boll motioned to affirm the boards previous decision and choose Ann as the new Director, seconded by Chris Brady, approved unanimously.

**Minutes:** There was a brief discussion on the 6/18/19 Regular Meeting minutes, motion to approve Stephanie Phillips Richter, seconded by Christine Fintzel, approved unanimously.

**Reorganization Paperwork and Meeting Dates:** The Town reached out about the completion of reorganization paperwork. That will need to be sent to the Town Clerk. The board discussed the setting of future meeting dates. The decision was made to not create a schedule, but rather schedule the regular meetings month-to-month.

#### Director's Report:

- The new flooring in the craft room has been laid down and the work is complete.
- The Library had a termite inspection. No termites were found.
- WorldBand came by to set up the laptops. We need to contact C/W Mars for a speed test of our internet connection. Speeds have seemed slow as of late.
- At the recent Town Department Head meeting it was discussed that we are still waiting
  on bids to be returned for the Library stairs and walkway. This may need a warrant for a
  special article at the next Annual Town Meeting.
- The Town's new centralized phone system will include the Library.
- There is a leak in the same spot that previous repairs were made.
- The Library's elevator passed inspection.
- We have put in a request for additional custodial staff.
- Northern Energy Services came by to inspect lighting and will send a report for recommendations. They will also look at our heating. This is through Mass Save.
- We are looking into a new refrigerator.
- C/W Mars signed and returned the annual contract.
- The Town Manager was made aware of the situation with the heating coils and MPC.
- We've had over 130 sign-ups for summer reading. We are looking into listing it on Facebook as an event.

Liz Valero has volunteered to lead an adult reading group.
