Mrs. Nietupski opened the meeting at 7:05 PM by reciting the pledge of allegiance.

Mrs. Nietupski welcomed the community members to the public forum. She explained open meeting law. She stated that the reason for this open forum was for parents, community members and teachers to offer suggestions or concerns regarding the reopening of schools.

2. Report of the Administration

Mr. Myers stated that he has received guidance from the Department of Elementary and Secondary Education for the reopening of schools. He stated that he received the initial guidance on June 25th and formed a task force with administrators, teachers, parents, and community members. The guidance included three types of plans for the district to create: in-school all students, hybrid, and remote learning. Mr. Myers stated that he divided the task force into four groups: Safety, Academic and Operations. The approved plan by the School Committee must be submitted August 10 to the Department of Elementary and Secondary Education. Mr. Myers stated that at the last School Committee meeting, the Committee voted to drop the in-person reopening plan on his suggestion. He stated that he does not feel that social distancing can be achieved if all students return to school.

3. Open Forum

Mrs. Nietupski opened the public forum. She stated that anyone that wished to speak must sign in and will have 2-12/ minutes. She stated that there would be questions entertained, only concerns or statements. She stated that the Chairperson reserves the right to ask you to stop if you are being out-of-order. She stated that no one should mention a name, no heckling, no applause and no booing should take place. Mrs. Nietupski stated she reserves the right to close the forum if there is any inappropriate behavior.
