
Town of Millbury Minutes of Sewer Commission Meeting October 23, 2018



CALL TO ORDER

Gary Nelson called the meeting to order at 5:05 p.m.

Mr. Stachura stated that if the board had any questions about operations that they can go to him for questions.

Gary also asked Mr. Stachura about the project on Stratford Village with the corrections that need to be made and Mr. Stachura stated that Keith Nastasia and he went around with the Engineer from Stantec to inspect the project and told him everything that needed to be fixed.

Chairman Nelson also spoke about the McGrath Road project and that the process of redesigning the plans to send to the DEP for approval.

Discussion took place on Cobblestone Village about getting the as builds and inspections done. Chairman Nelson asked for a letter to be sent to Mr. Temple project manager to find out what was going on.
