
# Town of Millbury Minutes of Sewer Commission Meeting June 25, 2019

# ITEM TEN – ADDITIONAL TOPICS

Chairman Nelson talked to the Board about Park Hill Ave – Clearview Plans and looking to see if flows can go into the City of Worcester's Sewer System and how much it would cost. Frank was meeting with Worcester on June 26, 2019 to discuss this process. Need to find out if the owner of Clearview will be picking up the cost of construction for the project. Frank Stachura told the Board that Park Hill Pump Station is at 100% capacity.

Chairman Nelson also spoke about the Elm Court Pump Station stating that National Grid is still holding this project up but the Town Manager scheduled a meeting with Nation Grid for Friday, June 28, 2019 at 8:30 am to see if this can be resolved. If not Chairman Nelson spoke with Ray Willis for possible upgrade of station instead of replace or just work on another pump station. Keith Caruso made a suggestion that the wires just be put underground to the generator that way the wires will not be damaged.

If the Elm Court project is going to be held up it was suggested that the other pump stations be worked on instead.

Chairman Nelson said he was talking to Andrew Vanni Finance Director about the MS Program to set up separate accounts.

Need to set Sewer Rate in July meeting. Discuss Quarterly Billing.
