
# Town of Millbury Minutes of Sewer Commission Meeting November 23, 2021

Chairman Gary Nelson called to order the meeting at 4:35 pm.

Denise asked why the bill was being abated and Chairman Nelson stated it is because she did not receive a meter deduction form. ## **ITEM EIGHT: ADDITIONAL TOPICS:**

Clerk showed the board a notice that will be sent out with the bills in January.

Meter Deduction forms were mailed out November 22, 2021 and will be due back December 17, 2021.

Chairman Nelson asked Keith about 126 Grafton Street. Keith stated that this portion of land was sold and subdivided the lot. There is no sewer on the lot itself. Keith will have a meeting with the new owners next week to discuss this project.

Chairman Nelson spoke about thing going on in town. About possible sewer going up 146. Chairman Nelson asked Keith about 14 School Street asking if it was the town's problem or the homeowner's problem. Keith stated it was the homeowner's problem. Keith stated that they called the office and was supposed to pull a permit.

Chairman Nelson spoke about a chalking pump at the main pump station to save wear and tear on the main pump station. There are grants to apply for that will be either 3 or 5 years. It will cost us \$36,000 out of pocket for the town's portion.

West Main Street sewer connection will cost about \$40,000.00. Which Chairman did not see a problem with but waiting for more information from the owners.

The violation letter that went out for McGrath Road was up on November 18, 2021 and did not hear back from them. Town Manager will speak with Town Counsel to see what the next process will be.

Chairman Nelson spoke about Rice Road, Singletary Arms and Canal Street. Clearview is still working on their project.

The next regular scheduled meetings will be held on December 14, 2021 and December 28, 2021. Meetings will be held the 2<sup>nd</sup> and 4<sup>th</sup> Tuesday of every month unless otherwise posted and/or cancelled.
