Main Street Pony Pump Project is on pause due to energy savings & cost savings.

GIS System for Sewer Mapping: is up and running. Mark is working with Frank to go through it to update some of the mapping, so if ever a problem there is a place to look and see where with a comprehensive map system. Not complete yet.

Elm Court Pump Station Project: We paid final payment on that and we are final owners of that pump station. It's operating as intended, so as of now there are no issues.

Warren Street Pump Station: There were bids received and we awarded the contract to Baystate Regional Contractors.

Rice Road Capacity Study: Residential project moving forward. Received state approval, so 2 things as far as the sewer goes, we still need to get the money from the developer for the first capacity study and now the number of bedrooms have jumped from 150 to 300. We need to ask developer to fund a new study so we can support that amount of flow in our system.


ITEM EIGHT – ADJOURNMENT:
