Yankee Engineering Contract.

Mr. Billings and Mr. Goulet reviewed the town's material and testing services procurement and bid results. The contract would be used for such things as concrete and metal fabrication testing. The firm will be assisting the town for the duration of the project. They reviewed the bids and determined the best value to be Yankee Engineering. The bid specifies up to \$120,000 contract terms. Hill International provided the committee will a full analysis of the bid results. Mr. Goulet spoke very highly of Yankee Engineering and has worked with them in the past. Committee members asked questions about the service and how they best value was determined. The bid was publicly bid according to the state procurement requirements. Mr. Billings stated that he would enter into a contract upon approval by the committee. Mr. Bedard stated he would open a new purchase order.

David Billings stated that Fontaine Bros, will be using ProCore software platform in order to track building construction progress and timelines.

David Billings introduced Jonathan Teixeira as a potential Site Supervisor to replace Marty Goulet. Jonathan's resume was included in the packet. David and Jonathan reviewed his resume and work experience, which included extensive work for Nauset Construction. Jonathan is a Sutton resident. Committee members

were very surprised to learn of this change in leadership at a very late stage as we are about to start construction. The Site Supervisor's tasks are about to start. Marty Goulet was one of the three key people when we hired Hill International to be our Owner's Project Manager. Committee member discussed the contract implications. Mr. Pine stated that any change in key personnel needs to be approved by the Owner and MSBA.
