In conformity with the requirements of Section 22 of Chapter 166 of the Massachusetts General Laws, you are hereby notified that a public hearing will be held in the Millbury Town Hall, 127 Elm Street, Millbury on **Tuesday, May 10, 2022 at 6 PM** on the Joint Petition NATIONAL GRID and Verizon New England, Inc requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

McCracken Rd- National Grid to remove 1 SO Pole on McCracken Rd beginning at a point approximately 45’ feet northwest of the centerline of the intersection of McCracken Rd and Greenwood St and continuing approximately 2800 feet in an east direction. Dot Road Project 605377-Remove SO pole along McCracken Rd

McCracken Rd- National Grid to install 5 JO Poles, remove 3 JO Poles, and relocate 21 JO poles on McCracken Rd, beginning at a point approximately 45 feet northwest of the centerline of the intersection of McCracken Rd and Greenwood St and continuing approximately 2800 feet in an east direction Dot Road Project 605377-Rem/Rep Poles along Greenwood St and McCracken Rd No. 18525348

Tainter Hill Rd – National Grid to install beginning at a point approximately 65 feet northwest of the centerline of the intersection of Tainter Hill Rd and continuing approximately 65’ feet in a south direction. DOT Road Project 605377-Installing new UG switchgear and relocating UG transformer along Tainter Hill Rd. Existing Switchgear to get backfilled.
