- Provide cost for removal of asbestos and hazardous materials by a licensed abatement contractor within the scope of proposed work area. MA DEP notification form, disposal documents and upon completion, provide an asbestos abatement report.
- Provide cost for Commissioning for PE Engineering Services to monitor and as need arises design recommendations.
- Provide cost for Selective Controlled Demolition of existing north side concrete masonry (CMU) parapet gable end wall down to top of window lintel or after review by your engineer down to suitable solid construction and haul debris from site to licensed facility. Site shall be cleaned up daily.
- ❖ Provide cost to construct a new 2x 6 wood frame wall, with ½-inch CDX plywood or approved equal and connect to existing gable roof framing, and flashing to prevent roof leakage. The new wall shall be anchored to the existing CMU wall, made weather tight with approved materials and flashing.
